❖ INTERNATIONAL STUDENT ADMISSION

Admission of international students to programs at Mus Alparslan University is carried out in accordance with the "Regulations on the Admission of International Students to Higher Education Institutions" prepared by the Council of Higher Education in accordance with Article 45/f of Law No. 2547 and the "Mus Alparslan University Directive on Admission of International Students to Associate and Undergraduate Programs"

❖ THOSE WHO CAN APPLY

A- With the condition of being in the final year of high school or being a graduate;

- 1- Foreign nationals,
- 2- Those who are Turkish citizens by birth but with a later permission for renouncement of nationality by the Ministry of Interior and those who provide evidence that their under age children registered in the document of renouncement of nationality have a Document on the Use of Recognized Rights by the Turkish Citizenship Law (Article 7 of the Turkish Citizenship Law no: 5901 states the following: "(1) Children who are born during the marriage of a Turkish mother or father in Turkey or abroad are Turkish citizens." and the candidates abroad to apply to admission quotas are advised to view the Turkish Citizenship Law.),
- 3- Foreigners who have had the right to the certificate of naturalization of the Turkish Republic as citizens / those who have dual nationality under similar conditions,
- 4- **a)** Turkish students who attended secondary schools abroad before the date of 01/02/2013, including those who have completed the last three years of their secondary school education in a foreign country except for Cyprus and those who have completed their whole secondary school education Turkish schools under the supervision of the Ministry of National Education (MoNE) in a foreign country except for Cyprus),
b) Candidates of foreign student admission quotas who started secondary school education abroad after the date of 01/02/2013, including those who have completed their whole secondary school (high school) education in a foreign country except for Cyprus and those who have completed their whole secondary school (high school) education Turkish schools under the supervision of the Ministry of National Education (MoNE) in a foreign country except for Cyprus),
- 5- Cyprus citizens who live in Cyprus and those who have completed their secondary school education in Cyprus high schools and have received GCEAL results and those who were registered at and attended private schools and high schools in other countries between 2005 and 2010 with GCE AL examination results or those who will receive such results,

❖ THOSE WHO CAN NOT APPLY

B- Those candidates expressed below can not apply;

- 1- Turkish students who have completed their whole secondary school education in Turkey or in Cyprus,
- 2- Cyprus citizens (except for those who have completed their whole secondary school education in Cyprus high schools and have received GCE AL results and those who were registered at and attended private schools and high schools in other countries between 2005 and 2010 with GCE AL)
- 3- *Those who have dual nationality, the first of which is Turkish by birth as stated in Article a, clause 2 (except for those who meet the conditions stated in Article A, clause 4)
- 4- Those who have dual identity, one of which is Cypriot, except for those who have completed their whole secondary school education in Cyprus high schools and have received GCE AL results and those who were registered at and attended private schools and high schools in other countries between 2005 and 2010 with GCE AL examination results or those who will receive such results),
- 5- Turkish citizens who attend schools in Turkey under the supervision of embassies and foreign high schools in Turkey or those who have dual identity, the first of which is Turkish by birth, as stated in Article a, clause 2.



❖ REQUIREMENTS FOR A SUCESSFUL APPLICATION

Applicants must meet at least one of the requirements stated in the table below for a successful application

15	Al-Shahada-Al Thanawiyya (Baccalaureate) exam done Libya	Having minimum 185 scores out of 240 in Science (Scientific Stream) for the departments of Engineering Faculty, getting at least 170 points for other departments.

❖ EVALUATION OF THE APPLICATIONS

The evaluation of the applications and the placement of the candidates are under the sole authority of Muş Alparslan University. Candidates with missing documents are not taken into consideration. Placement procedures are carried out by the International Students' Placement Commission of our university.

- 1- Placement is made according to score superiority and order of preference. In case of equality in these criteria, the younger candidate is given priority.
- 2- Candidates can only be placed in one programme.
- 3- Meeting the application requirements does not give the right to be placed in the programme.
- 4- If necessary, Muş Alparslan University may make additional placements other than the placements in the calendar specified in this guide. Details regarding additional placement are announced on the web page of our university.
- 5- Candidates will be able to view the placement result by logging in through the system on the announced date and print their acceptance letters through the system. No acceptance letters will be sent to the students by our university.

- 1- One-year compulsory English Preparatory Programme is applied. The preparatory year is not included in the years shown in the education period column. Those who pass the English proficiency exam are directly admitted to the first year. Students are subject to the provisions of the 'Regulation on Foreign Language Teaching in Higher Education Institutions and the Principles of Teaching in a Foreign Language'.
- 2- One-year compulsory Arabic Preparatory Programme is applied. The preparatory year is not included in the years shown in the education period column. Those who pass the Arabic proficiency exam are directly admitted to the first year. Students are subject to the provisions of the 'Regulation on Foreign Language Teaching in Higher Education Institutions and the Principles of Teaching in a Foreign Language'.
- 3- The language of instruction in this program is at least 30% Arabic Language.

Turkish Proficiency Exam

- 1- A Turkish Proficiency Exam will be held by Muş Alparslan University Turkish and Foreign Language Teaching Application and Research Centre (MAUN-TÖMER) for students who have the right to register to our university.
- 2- It is necessary to score at least B2 in order to begin the programme directly.
- 3- Students who have Turkish proficiency certificates for these levels through other universities or public institutions do not need to take the exam.
- 4- Those who have completed their high school education in Turkey (except Open Education High School) or those who graduated from Turkish-medium high schools abroad are not required to submit a document.
